



**PROPERTY DESCRIPTION  
60' PERMANENT DRAINAGE AND UTILITY EASEMENT**

Being a 34,426 square feet tract of land situated in Section 5, Township 8 South, Range 5 West, Jackson County, Mississippi, and being a portion of that land conveyed to Janie Baugh and Carolyn Baugh McCorkle, as recorded in Deed Book 1568, Page 885, and Susan Manyoky, as recorded in Deed Book 1468, Page 457, Deed Records, Jackson County, Mississippi; as shown on survey by Paul D. Pitts, Jr., dated September 21, 2016, whose basis of bearings is the Mississippi State Plane Coordinate System, East Zone (2301), NAD 83 (2011 Epoch 2010.00), Geoid 12A, grid values, using a scale factor of 0.999961331 and a convergence angle of 00 degrees 09 minutes 33 seconds determined specifically for this project using GPS methods from a Base Station located at N338,182.184, E1,112,070.489 obtained from the USM Network, and being more particularly described as follows:

Commencing at a 1/2 inch iron rod found for the northwest corner of the northeast quarter of the northeast quarter of Section 5, Township 8 South, Range 5 West, same being the northeast corner of Briarwood Estates, as recorded in Plat Book 12, Page 30, Plat Records, Jackson County, Mississippi;

Thence, along the east line of said Briarwood Estates, South 00 degrees 22 minutes 09 seconds East a distance of 452.98 feet, to a 1/2 inch iron rod set for the Point of Beginning of the herein described tract;

Thence, North 89 degrees 37 minutes 51 seconds East a distance of 60.00 feet, to a 1/2 inch iron rod set for corner;

Thence, 60 feet from and parallel with the east line of said Briarwood Estates, South 00 degrees 22 minutes 09 seconds East a distance of 519.02 feet, to a 1/2 inch iron rod set on the north line of a tract of land conveyed to Lighthouse Baptist Church, as recorded in Deed Book 1591, Page 598, Deed Records, Jackson County, Mississippi;

Thence, along the north line of said Lighthouse tract, South 89 degrees 43 minutes 47 seconds West a distance of 43.84 feet, to a 1/2 inch iron rod set for the northwest corner of said Lighthouse tract;

Thence, along the west line of said Lighthouse tract, South 00 degrees 22 minutes 09 seconds East a distance of 196.60 feet, to a 1/2 inch iron rod set on the north right-of-way line of Old Mobile Highway;

Thence, along said north right-of-way line, South 49 degrees 38 minutes 20 seconds West a distance of 21.10 feet, to a 1/2 inch iron pipe found on the aforementioned east line of said Briarwood Estates;

Thence, along said east line, North 00 degrees 22 minutes 09 seconds West a distance of 729.11 feet, to the Point of Beginning and containing 34,426 square feet of land.

The basis of bearings for this survey is the Mississippi State Plane Coordinate System, East Zone (2301), NAD 83, Geoid 12A, grid values, using a scale factor of 0.999961331 and a convergence angle of 00 degrees 09 minutes 33 seconds determined specifically for this project using G.P.S. methods from a base station located at N338,112.184, E1,112,070.489 obtained by the USM Network.
2. This survey was prepared without the benefit of a Title Search.
3. Date of this Mississippi Standards Class B Survey is July 11, 2016.
