Old Business:

Prepared Food Tax Collection: Jay Spradlin presented the prepared food tax collection information: \$4,266,735.34 received from 2/2017-1/15/2021. December Receipts \$90,595.66 Hotel/Motel Tax Received 8/19-1/1/2021 \$256,985.48 December receipts \$14,288.79.

Sportsplex: Still have a couple punch list items to complete. Parking lot lights have been approved to be installed in the Jackson Street parking lot.

MCC Park: Basketball Court rules sign has been ordered and will be installed. Athletic director along with engineer examined the wet the spots on the basketball courts and came up with a solution of putting a squeegee out to help dry the courts.

I.G. Levy: Getting estimate to replace lighting thru Mississippi Power. Electrician will start work soon on the electrical box to restore some of the power that was lost when tennis building was torn down.

Point Project: Task order approved. Obtaining permits for the project. Permits should take up to 90 days.

New Business:

- A. Program Updates: Athletics- Basketball going great. Volleyball Academy is full with waitlist. Looking to add a volleyball camp this summer. Programs Spring Break registration is open. Summer Camp Registration scheduled to open March 1.
- B. Maintenance Updates: The benches for IG Levy Tennis courts have been installed. Maintenance Crew has started spreading the mulch at IG Levy.
- C. League Facility Use Agreement: Rec Commission reviewed
